(Revenue \$) Innovative Educator Network The Fund continues to support principals and their educator teams as they use innovative models to personalize instruction, accelerate student learning and move their public schools into the 21st century. In 2015, The Fund conducted a third cycle of its Summer Design Program (SDP), which enabled 40 public school teams to take part in a summer-long workshop series designed to help them implement small-scale innovations within their classrooms and schools. Following the SDP, The Fund offered continued programmatic and financial support to 25 schools; projects supported through this initiative included the expansion of personalized and blended learning strategies; the restructuring of physical classrooms; different approaches to class

4b (Code:) (Expenses \$ 1,095,304. including grants of \$) (Revenue \$) Principal Quality Initiative The Fund continues its support of increasing the number of high-performing principals in Chicago's public schools to 350 by 2018. In 2015, this included work to improve the retention of Chicago's top-performing public school principals through the Chicago Principals Fellowship. The Fellowship, which is a partnership between The Fund, Crown Family Philanthropies, Chicago Public Schools, and Northwestern University, is an executive-level leadership development program intended to grow the skills of top principals and further expand their leadership capacity. Twenty principals participated in the Fellowship during 2015; ten percent of the city's principals are intended to participate over the three-year program. The Fund also worked to inform

4c (Code:) (Expenses \$ 479,103. including grants of \$) (Revenue \$) Educator Engagement The Fund works to engage educators as much as possible and to establish the fundamental conditions necessary to enable high-performing principals to transform schools. In 2015, The Fund focused on elevating the stories of the city's top-performing principals through several reports, including its Summer Design Program Report and Profiles in Schools Leadership: Leveraging Student-Based Budgeting report. The Fund also invested resources in its Educator Advisory Committee (EAC), designed to inform Fund strategy and program. In 2015, the EAC included educators from public schools citywide.

The Fund acted as a fiscal agent for Chicago Public Schools (CPS) in connection with the CPS principal bonus plan that began in 2012. This agreement provided that The Fund would accept payment of pledges from various donors secured by CPS, and would process annual bonus payments to school principals, as directed by CPS. During 2015, donations in the amount of \$276,666 were collected from donors and recorded to the statements of financial position as a liability, and \$435,000 was disbursed for principal bonus payments. After the bonus payments to principals were made in 2015, CPS and the donors agreed to terminate this agreement, and The Fund refunded the remaining \$270,666 of unspent funds to the donors.

Part XIII Supplemental Information (continued)

Additionally, during 2014, The Fund agreed to serve as fiscal agent on behalf of Crown Family Philanthropies (Crown) with respect to the CPS Principal Fellowship Program in partnership with Northwestern University. The second of two \$200,000 payments was received in 2015. In 2015, \$300,000 was disbursed under the direction of Crown, leaving a balance of \$100,000 to be disbursed over the remaining term of the agreement, which ends in October 2016.

Part X, Line 2:

The Fund is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and applicable state law. In addition, The Fund qualifies for the charitable contribution deduction under Section 170(b)(1)(A) and has been classified as an organization that is not a private foundation under Section 509(a)(2).

The accounting standard on accounting for uncertainty in income taxes addressed the determination of whether tax benefits claimed on a tax return should be recorded in the financial statements. Under this guidance, The Fund may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. Examples of tax positions include the tax-exempt status of The Fund and the various positions related to the potential sources of unrelated business taxable income (UBTI). The tax benefits recognized in the financial statement from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The Fund does not believe

that there are any unrecognized tax benefits or tax liabilities that should be recorded for the reporting periods presented in these financial statements.

The report summarized findings about the principal turnover rate in Chicago and provided four recommendations to help retain principals longer in their roles. With support from The Fund, the Chicago Public Schools Principal Quality Working Group built upon the 2015 School Leadership Report's call to improve principal supports, recommending a menu of differentiated professional development options to better meet the needs of all sitting and aspiring principals. The Fund's efforts have helped secure 212 high-quality principals leading Chicago's public schools, a more than 40 percent increase since this work began in late 2013.
